1. FFCC Outreach Trip Contract

- Sign the original and have it notarized. (The original, notarized copy will be carried by FFCC staff on the field during travel)
- Send the original back to FFCC

- Make a photocopy for the minor to carry with him/her
- Make a photocopy for the parent/guardian to keep

2. FFCC Travel Release form for Adults or Minors

- Make a photocopy for the minor to carry with him/her
- Make a photocopy for the parent/guardian to keep

3. FFCC Minor Travel Authorization Form

- Sign the original and have it notarized. (The original, notarized copy will be carried by FFCC staff on the field during travel)
- Send the original back to FFCC

FFCC Outreach Trip Contract

By signing this contract, I am indicating that the adult or minor would like to participate in an FFCC Outreach Trip, and committed to obtain all the funds necessary to do so. I/we realize that all funds that are obtained for this FFCC trip are considered as charitable contributions to FFCC (a non-profit organization), and therefore are the property of FFCC for federal income tax purposes to the extent permitted by law. Tax deductible contributions will not be refunded.

We realize that all checks should be made payable to FFCC and sent to 12463 Rancho Bernardo Rd. PMB 158, San Diego, CA 92128, and that all funds will be administered as a personal "FFCC Outreach Account" in the adult or minor's name for this FFCC trip. We understand that this account will be established upon approval of the adult or minor's application, and the receipt of \$300.00 non-refundable deposit. FFCC may increase the price of the Outreach Trip upon notice to participants.

If the adult or minor is able to participate in the FFCC Outreach Trip, the Trip price, established by FFCC, and any expenses incurred by FFCC on the adult or minor's behalf for this FFCC Trip, will be deducted from the adult or minor's FFCC account. I/we will submit

- 50% of FFCC Outreach Trip price (after \$300.00 deposit) at least 60 days prior to the trip departure date
- All remaining FFCC Outreach Trip price at least 30 days prior to the trip departure date.

In the event that funds exceed the Outreach Trip price by \$200.00 or more, we understand that the adult or minor may request such funds be applied as a non-refundable deposit toward a future FFCC Trip before the end of the next calendar year. These funds will be moved to a pending FFCC Outreach account. No interest will accrue for funds left in a pending FFCC account. Any funds not used by the end of the following calendar year will be used to further the work of FFCC and all records of the adult or minor's FFCC Outreach account may be discarded. In the event that funds raised exceed FFCC Outreach Trip costs by less than \$200.00, such excess funds may be used, by FFCC to cover other FFCC expenses.

In the event that the adult or minor does not participate in the FFCC Outreach Trip, any expenses incurred for the adult or minor or on the adult or minor's behalf (airline cancellation fees, deposits, etc.) will be deducted from the adult or minor's FFCC Outreach account, and will be responsible for any deficit. I/we will pay any deficit within fifteen (15) days following notice to the adult or minor of the amount of such deficit. Any funds remaining in the adult or minor's FFCC Outreach account, after all of the adult or minor's expenses are paid, may be used in the way described in the previous paragraph.

I/we understand that FFCC is a community organization built on Biblical values and believes that the Bible commands to make every effort to live at peace and resolve disputes with each other in private or within the Christian church (Matthew 18:15-20, Corinthians 6:1-8). Therefore, I/we agree that any claim or dispute arising from or related to this Contract or any FFCC Outreach Trip in which the adult or minor participates shall be settled by biblically based mediation. All such mediation and arbitration shall take place in San Diego. Judgment upon an arbitration award may be in any court otherwise having jurisdiction. We understand that these methods shall be the sole remedy for any controversy or claim arising out of this Contract or any such FFCC Outreach Trip and we expressly waive any rights we have to file a lawsuit in any civil court for such disputes, except to enforce an arbitration decision

FFCC Outreach Trip Release Form for Adult or Minor

1. Release of Liability

I/we the undersigned, desiring that _____ (the “adult or minor”) be allowed to visit foreign countries with Friends and Family Community Connection (FFCC) and participate in an Outreach Trip organized by FFCC do hereby release and forever discharge FFCC staff, directors, employees, volunteers and representatives from any and all claims for any and all injuries, losses or damages the minor might have no or in any way relating to such trip, including, without limitation, those relating to the minor leaving the United States of America and visiting foreign countries, including the adult or minor’s stay in any such foreign country and the adult or minor’s trip to and from any such country.

We are/I am (18) years of age or older, and this Release is binding on the undersigned and the executors, administrators, and heirs of the undersigned.

2. Medical Authorization

The undersigned give FFCC and it’s representative(s) (with the adult or minor on any such trip) authority to request and authorize medical and/or hospital treatment for the benefit of the adult or minor in the event of any injury or sickness sustained by the adult or minor while on such trip, including, all such treatment and to reimburse FFCC for all costs and expenses incurred by it with respect to such treatment.

3. Binding Arbitration

I/we understand that FFCC is a community organization built on Biblical values and believes that the Bible commands to make every effort to live at peace and resolve disputes with each other in private or within the Christian church (Matthew 18:15-20, Corinthians 6:1-8). Therefore, I/we agree that any claim or dispute arising from or related to this Contract or any FFCC Outreach Trip in which the minor participates shall be settled by biblically based mediation. All such mediation and arbitration shall take place in San Diego. Judgment upon an arbitration award may be in any court otherwise having jurisdiction. I/we understand that these methods shall be the sole remedy for any controversy or claim arising out of this Contract or any such FFCC Outreach Trip and I/we expressly waive any rights I/we have to file a lawsuit in any civil court for such disputes, except to enforce an arbitration decision
