LGC is committed to Privacy

Your privacy is important to us. The LGC websites www.mainestandards.com, www.myCalVer.com, <https://msdrx.mainestandards.com>, (hereafter “**Site**”) are controlled and operated by LGC Maine Standards (which, along with other LGC Group Affiliate companies, is referred hereafter as “**LGC**”, “**we**”, “**us**” and/or “**our**”).

This Privacy Notice explains our online information practices. This includes a description of the types of personally identifiable information (hereafter “**PII**” or “**Personal Data**”) data we may collect, how we may use it, with whom we may share it and how you can make choices about the way your Personal Data is collected and used.

This Privacy Notice applies to all PII collected or submitted on this Site. Links within this Site to other websites (including other LGC sites) are not covered by this Privacy Notice. To make this Privacy Notice easy to find, we make it available on our homepage and at every point where personal information may be requested.

The Personal Information we collect

This Privacy Notice applies to all Personal Data collected or submitted on this Site including information you provide voluntarily to us and information we may collect from your use of our Site. The Site allows you to order products, make requests for information or contacts and register to receive LGC research and materials.

We may obtain the following types of Personal Data:

- Name;
- Job title and Employer’s name;
- User-Defined Password Recovery Information;
- Digital Signature;
- Work or Other Address;
- Work or Other Email address;
- Work or Other Phone number;
- Browsing information [relating to your use of the Site; and
- Internet Protocol (IP) address of your Internet Service Provider

How we collect Personal Information

We collect Personal Data through:

- Your voluntary input of your personal information on the Site;
- The use of cookies (as explained in more detail below); and
- Technologies such as Google Analytics

Cookies

Like most websites, the Site uses cookies on the Site helps improve your experience by catalogue traffic patterns. They ensure you are provided with an enhanced customer experience each time you return to visit our Site. The cookie assigns a 'User ID' to your computer and allows us to distinguish you from other users of the Site. However please note these cookies, by themselves, cannot be used to establish the identity of any user. The assignment of a cookie to your computer allows our Site servers only to identify your computer automatically when you visit our Site. Unless you have specifically told us who you are, the cookie will not let us know who you are.



You can set your browser settings to alert you before a cookie is placed on your computer or to reject cookies but please note that this may restrict your ability to use all features of the Site.

The way we use Personal Information

We may use the Personal Data we have collected to:

- Fulfil the orders you have placed with LGC;
- Improve the Site and customer experience (i.e. troubleshooting) and enable LGC to identify and prevent future issues;
- Communicate with you (respond to any emails you may send to us i.e. access or account requests); and
- Compile and analyze trends on the Site

The Personal Data we obtain is used for the purposes (as described above) for which you have given your consent, except where otherwise permitted by applicable privacy laws. LGC does not sell on details of our customers and we will contact you about LGC products and services only when it is lawful for us to do so. Where necessary we will seek your consent to use your Personal Data for marketing purposes.

You can register with our Site if you would like to receive our catalogue as well as updates on our new products and services.

Please note that providing personal information to us is voluntary on your part. If you choose not to provide your details to us, we may not be able to make you aware of special offers or new products and services.

LGC's legal basis for processing your Personal Information

Our legal grounds for processing your Personal Data for the purposes described above will typically be one of the following:

- Your consent;
- Performance of a contract with you;
- Our legitimate business interests; or
- Compliance with a legal obligations.

Sharing Personal Information

Your personal information may be shared within the LGC Group of Companies. We only share Personal Data, with outside parties to the extent necessary, to fulfil orders, follow up with relevant information on products, services or training courses with third parties who perform specific functions on our behalf. We will never sell your personal information to outside parties.

If we disclose your Personal Data to any outside parties, we will ensure that this sharing is protected under an appropriate contract so that your Personal Data is only used by such outside parties in connection with the services they are delivering on our behalf. Please note that we are not responsible for the privacy practices of outside parties – such practices are subject to their respective privacy policies, but we do seek to work with trusted partners whose practices and values reflect our own.

Please note that your Personal Data may also be disclosed under special circumstances to governmental bodies in order for LGC to comply with legal or regulatory requirements.

Transfers of your Personal Information outside of the EU

As noted below, you may also choose to exercise other rights you may have under applicable law – such as the right to access, correct, or delete your Personal Data.

Your rights to access, correction and objection

You have the right to request access to the Personal Data we hold about you at any time by emailing data.protection@lgcgroup.com and stating your name and the name of this Site. We will take reasonable efforts to provide you with a summary of any Personal Data collected by us. Depending on the nature of your request, this may take up a month for us to deal with, from when we have completed the required verification of your identity and the scope of your request.

While we always endeavor to take reasonable steps to ensure your Personal Data is kept up-to-date and accurate, you have the right to request correction of any Personal Data that is incorrect.
