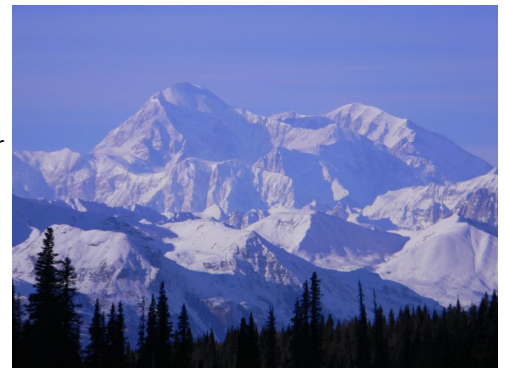

Because of Denali's size, it generates its own weather, often meaning it is covered in clouds...only about 30% of visitors actually see the mountain. But with 3 nights in the park, this is your best chance to see the majestic mountain! Overnight for 3 nights at McKinley Chalet Resort.

Day 3, Friday, Aug. 5: Denali. Today is a treat as you join the unforgettable Tundra Wilderness Tour. This 6-8 hour fully narrated sightseeing excursion takes you as far into the park as any tour operator goes, giving you the very best shot of seeing the mountain and Denali's iconic wildlife.

Day 4, Saturday, Aug. 6: Denali. Because Denali National Park has so much to offer, you have an entire free day to explore. Relax around the town square or join an optional excursion, such as midnight golfing, ATV adventure or fly fishing.

Day 5, Sunday, Aug. 7: Board Cruise. Enjoy some of Alaska's most spectacular scenery as you travel via luxurious domed rail cars from Denali to Whittier where you will board your home for the next week, the Nieuw Amsterdam. Keep your eyes peeled for Alaska's Big 5: grizzly bears, moose, caribou, Dall sheep and gray wolves.

Day 7, Tuesday, Aug. 9: Glacier Bay. Close your eyes and take in the sounds—the creaks and groans of “living” ice, the shrill cries of gulls and soaring eagles, the splash of a breaching humpback whale....this is Glacier Bay! Make sure to bring the binoculars to see glaciers, fjords, inlets, rivers, streams and wildlife galore on your 8-hour visit to Glacier Bay.

Day 8, Wednesday, Aug. 10: Skagway. At the height of the Klondike Gold Rush, Skagway served as the primary gateway to the legendary gold fields and you can still explore the colorful history, pristine wildlife and unrivaled natural beauty of the town. You have the day free to explore on your own or join one of the optional excursions, which include the White Pass Rail, sled dogs visit or culinary tour, just to name a few.



Day 9, Thursday, Aug. 11: Juneau. This sleepy, misty capital city of 32,000 residents is the most remote and beautiful of the state capitals. Surrounded by water, forest and mountains, there is no shortage of activities. Optional excursions include salmon fishing, Mendenhall Glacier and gold panning.

Day 10, Friday, Aug. 12: Ketchikan. Named Alaska’s “First City” because it’s the first major landfall for most cruisers as they enter the picturesque fjords of the Inside Passage, Ketchikan has long been an important hub for salmon fishing. This is also one of the best spots to explore the rich cultural sights of Native Alaskan nations like the Tlingit, Haida and Tsimshian. Learn how to carve totem polls or enjoy a native dance show....the day is yours.



Day 11, Saturday, Aug. 13: Cruising The Inside Passage. You will cap off your adventure with a full day of scenic Inside Passage cruising while enjoying the activities aboard Holland America. Wailing the Inside Passage offers opportunities to spot some of Alaska’s most iconic wildlife, with humpback whales and orca playing the bountiful waters, bald eagles soaring overhead and brown bears lumbering on the shoreline.

Day 12, Sunday, Aug. 14: Vancouver and Depart for Home. It is time to say good-bye to this beautiful part of the world. But if you are not ready for the adventure to end, ask your Burkhalter Travel Advisor about extending in Vancouver.

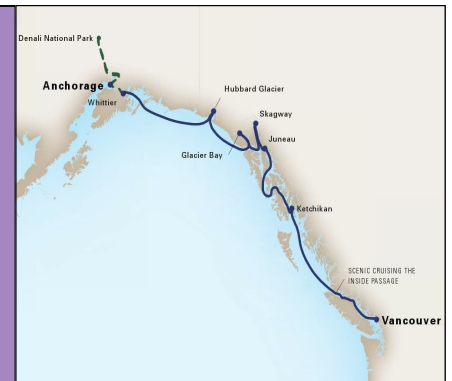

TOUR TERMS AND CONDITIONS - PLEASE READ CAREFULLY

I.D./Citizenship: Travelers must possess a passport book (not card) that is valid for at least six months beyond the tour's conclusion with names matching those on their tour and flight reservations. Complete name, gender and birth date are required to confirm reservations per TSA/airline requirements. It is recommended that any person charged with, or convicted of, a crime (including DUI) obtain the necessary approval before attempting to enter Canada. Non-U.S. citizens are responsible for confirming their own entry requirements.

Deposits and Payments: Please make checks payable to Burkhalter Travel. Most major credit cards are also accepted, although sometimes a cash discount may be offered. **A deposit of \$600 per person** is required to secure reservations. All tour confirmations are subject to receipt of signed tour application and payment verification. **Final payment is due by April 25, 2022.**

Cancellations/Refunds: All cancellations are subject to a \$50 Burkhalter Travel service fee that may not be covered by tour operator insurance. In addition to the service fee and possible airline penalties, tour cancellation penalties are as follows:

Cancel prior to April 25, 2022: Deposit is refundable

April 26—May 19, 2022: Deposit and airline fees are non-refundable

May 19—June 3, 2022: 50% non-refundable plus airline fees

June 4—July 3, 2022: 75% non-refundable plus airline fees

Cancel after July 4, 2022 : Trip is non-refundable

No refund will apply on unused portions of the tour. If a roommate cancels, the remaining traveler may have to pay any single room supplement that is incurred. Name changes and departure date changes are considered reservation cancellations and are subject to cancellation fees. Once issued, airline tickets are 100% non-refundable.

Tour Insurance: Travel insurance is strongly advised in order to protect your investment. Coverage for trip cancellation/interruption/delay, and medical emergency expenses is available from Burkhalter Travel, and we recommend purchase at the time of booking. Ask your agent for more information.

Tour Conditions: This tour is a regular Holland America tour departure and no minimum number of Burkhalter travelers is required to operate. All arrangements are based upon tariffs in effect on January 15, 2021 and are subject to change. Once deposit has been received, any changes to air or land arrangements may be assessed a \$50 revision fee. Revision fees may be higher once air is ticketed.

Accommodations/Coach Transportation: Generally, first class Westmark hotels are used throughout and include private ensuite facilities, typically with two beds. Touring coaches are deluxe vehicles with panoramic windows and seats that partially recline. Single travelers are allocated one seat only.

Traveler Fitness: Travelers should be in reasonably good health, able to board a motorcoach in a timely manner, climb stairs and walk moderate distances. Individuals with physical and/or cognitive limitations must be accompanied by an able individual who will assume complete responsibility for them - tour personnel cannot and will not provide such assistance.

Passenger Consent Agreement: Department of Transportation regulations require that we inform you that your purchase is subject to supplemental price increases beyond our control that may be imposed after the date of purchase. Such increases may come about due to increased fees, fuel surcharges, government tax increases, fluctuations in foreign exchange markets or any combination of these events. Post-purchase price increases may be applied to your invoice due to these unforeseen cost increases from suppliers. While a post-purchase price increase is very rare and not anticipated, Burkhalter Tours will inform you of any increases as soon as possible. By signing the tour application and making your deposit, you are acknowledging that you have been made aware and accept the fact that such increases may occur, and that you agree to pay Burkhalter Tours and our contracted suppliers accordingly.
