2020 Day Tours – Covid19 Safety Guidelines & Procedures

Your safety and health are our most important concerns. We have developed these guidelines in accordance with safety recommendations provided by the Missouri Department of Health, CDC, and our travel partners. While the Covid19 situation has caused great concern, there are still excellent safety measures that can be implemented for our program. We hope this will provide you with the comfort to continue to travel, and to be aware of your requirements to help keep everyone safe. Thank you for your understanding.

Effective for all 2020 Trips. GalaxSea will request that each customer read and understand the guidelines set forth and to adhere to the regulations within.

- If you are sick, or have any flu or cold symptoms (cough, sore throat, fever, or any other cold and flu type symptom), please do not travel. Stay home and get well.
- If you have tested positive for Covid19, or been exposed to another person who tested positive, please follow the CDC quarantine guidelines (you can read on the cdc.gov website). 14 days if you tested positive. 14 days if you have been exposed to someone else who tested positive (14 days since your exposure).
- Our coach seating will be reduced to 30 travelers. This will allow us to provide some extra spacing throughout the coach. If we receive clearance that spacing is not required, we will adjust this to accommodate more.
- Until further notice, travelers will be requested to wear a mask while boarding and offloading the coach; while moving inside the coach to/from your seat or bathroom; and where required during our travels (at a theatre, event, restaurant, etc.). While eating, drinking, and during travel on the coach, or any other place were permitted - you can remove your mask if you wish too.
- All venues, including our Viking Motor Coach will have their own guidelines, and policies. We will need to adhere to those guidelines when traveling.
- All venues, including Viking, will have enhanced safety procedures in place, which includes cleaning protocols, greater access to hand sanitizer, limitations for spacing requirements, as well as PPE for most staff. Because of the variety of places and venues we may visit, including different states, these procedures and policies may differ from each other, including your home state.
- GalaxSea Cruises & Tours and their representatives will also wear masks, provide access to hand sanitizer, and be available to assist you during the trip. We will also be able to provide last minute information regarding the specific safety requirements at our destination(s) and to help ensure measures are followed appropriately.
- All of these protocols may change from time to time. We will provide an updated safety list as we prepare for each trip. This information may be distributed ahead of time, or it may be handed out on the day we travel. We will do our best to update you as quickly as we can.
